'International Trust Disputes' book co-edited by leading Cayman lawyers presented to the Chief Justice

Cayman-based lawyers Morven McMillan and Sara Collins have between them a wealth of knowledge and experience in international trusts and succession law. The two, with their co-editors Steven Kempster and Alison Meek, spent the best part of two years tapping into that knowledge to edit and contribute to a reference book by Oxford University Press entitled 'International Trust Disputes' that is described by one reviewer as "*an important book*" which "*enhances one's understanding of international trust disputes*". The book provides a detailed analysis of particular issues which arise in the context of international trust disputes while jurisdiction specific chapters deal with the way that those issues are dealt with in a wide range of on and offshore jurisdictions, including the Cayman Islands.

Ms McMillan, Partner and Head of Trusts & Private Client at the Cayman Islands office of Mourant Ozannes and Ms Collins, formerly a Partner and Head of Trusts & Private Client in the Cayman Islands office of Conyers Dill & Pearman, together with another of the book's contributors Carlos de Serpa Pimentel, Partner and Practice Group Head of Trusts with Appleby, recently presented the Honourable Chief Justice Anthony Smellie QC, JP, with a copy for donation to the Law Courts' library.

The Chief Justice was joined by Justice Charles Quin QC, Justice Alex Henderson QC and Court Administrator Kevin McCormac, and was pleased to receive the book:
